#### Aims

Doncaster Education Service Ltd T/A Tutor Doctor East Doncaster aims to establish and maintain safe working amongst staff, tutors and students

### Roles and responsibilities

Doncaster Education Service Ltd T/A Tutor Doctor East Doncaster is responsible for maintaining a Health and Safety policy.

The staff and tutors have a duty to take care of students in the same way that a prudent parent would do so.

Staff will:

- Be familiar with the Doncaster Education Service Ltd T/A Tutor Doctor East Doncaster Safeguarding Policy
- Take reasonable care of their own health and safety and that of others who may be affected by what they do at work
- > Co-operate with schools on health and safety matters as required
- Work in accordance with instructions
- Inform the Doncaster Education Service Ltd T/A Tutor Doctor East Doncaster office or a member of staff onsite of any work situation representing a serious and immediate danger so that remedial action can be taken
- Understand emergency evacuation procedures as appropriate and feel confident in implementing


#### Tutors

- > All tutors must have an Enhanced DBS
- > All tutors must have undergone Level 1 or higher safeguarding training
- Before working with schools, the tutor and their Education Consultant will read though the Safeguarding and Child Protection policy together

## Working With Complex Needs

Where necessary, individual student risk assessments will be completed to ensure the complete safety of tutors, students and other individuals present. Risk assessments will prioritise health and safety, any matters around safeguarding should refer to the Company safeguarding policy in a timely manner.

- > The video conferencing service should be a well-known, established service
- The video conferencing service should have a waiting room, so that only the designated student can be allowed to join the on-line lesson
